## Acknowledgment and Assumption of Risks and Agreement of Release

Challenge Course / Climbing Wall / Zip line and Related Equipment and Activities at the Springwood Outdoor Adventure Camp by Waypoints Inc.

I understand that injuries, both emotional and physical can result from my involvement in Challenge Course / Climbing Wall / Zip line and/or related experiences and activities at the Springwood Outdoor Adventure Camp by Waypoints Inc. I understand that I may suffer bodily injury including breaks, sprains and strains, bruises and, in extreme cases, emotional upset, anxiety and even death.

I understand that I may choose not to participate, and may withdraw from an activity for any reason whatsoever.

Understanding the activities, risks and possible losses or outcomes, and acknowledging that the risks described are inherent in the activities, and that other risks may exist, I nevertheless assume all such risks, inherent or otherwise, whether or not described above, and voluntarily choose to participate in these activities. **This is an expressed assumption of risk and, to the fullest extent allowable by law, it is my intent that by assuming such risks I relieve Waypoints Inc. staff, facilitators and others associated with it from any duty to protect me from such risks.**

Further, I, for myself, my heirs, executors, administrators and assigns hereby release and forever discharge the Waypoints Inc. staff, facilitators and others associated (hereafter "Released Parties") with it from any and all claims, damages, demands, actions or causes or action for physical or emotional injury, death or any other loss suffered by me or my property related in any way to my enrollment, participation or attendance at the activities and use of facilities, equipment and premises.

**The Release described above include claims arising in whole or in part from negligent acts or omissions of a Released Party.**

I have carefully read this document and have voluntarily signed it to reflect my full agreement to its terms.

**If the participant is under 18 years of age, a parent or guardian must sign below reflecting his or her agreement as follows:**

- a. That the parent or guardian joins in this agreement, including the acknowledgement and assumption of risks and agreement of release, on behalf of himself or herself and on behalf of the minor child.
- b. That in joining in this agreement the parent or guardian releases any claims he or she may have arising out of any loss or injury to the child.
- c. That the parent or guardian has explained to the child, to the extent he or she deems necessary, the nature of the activities, the hazards, and the possible outcomes and the child has confirmed that he or she is participating voluntarily and does hereby assume all such risks inherent or otherwise.
